FUND MANAGER'S COMMENTS

The Fund (Class MYR) rose 0.05% during the month of June 2018, underperformed the benchmark which was up 1.03%. Year-to-date, the Fund is up 1.05%. Stock selection in the underlying US funds contributed the most to outperformance.

Macro-economic data was mixed. Manufacturing Purchasing Managers Index (PMIs) remained in expansionary mode but are showing dropping momentum which the trade uncertainty could be a key factor. Economic surprises turned slightly negative and breadth weakened. Global financial conditions tightened further. The Federal Open Market Committee (FOMC) hiked its target rate 25 basis point as expected (new range 1.75-2%). The interest on excess reserves was increased 20 basis point to keep the transacted funds below the upper bound. European Central Bank (ECB) promised to keep rates at current levels at least through the summer of 2019 (dovish), tapered its net Asset Purchase Program (APP) to EUR15 billion a month in 4Q18 from EUR30 billion. Bank of Japan (BOJ) downgraded its inflation outlook to 0.5-1.0%.

The Fund is slightly overweight in the US and Japan while underweight Europe.
