

## TERMS & CONDITIONS

### 1. CONTEST PERIOD

#RunAcrossAsia #ResolutionRun 2020 Contest ("Contest") is organised by Sun Life Malaysia Assurance Berhad and Sun Life Malaysia Takaful Berhad ("Company") from 22 August 2019 to 17 November 2019, 11:59PM ("Contest Period").

### 2. ELIGIBILITY

- The Contest is only open to registered participants of Sun Life Malaysia Resolution Run 2020 who registered within the Contest Period only ("Eligible Persons"). Eligible Persons who participate in the Contest shall be referred to as the "Participants".
- The Participants will need to have completed the Registration Form (as defined below) with **ALL THREE (3)** Contest questions answered.
- The Participants must have a valid passport and relevant documents to attend their chosen Resolution Run destination.

### 3. CONTEST MECHANICS

The Contest is only open during the Contest Period and any entries after the Contest Period shall not be entertained.

The Participants are required to complete the following:

- A. Register for Sun Life Malaysia Resolution Run 2020 by 17 November 2019.
- B. Complete the online registration form @ [bit.ly/ResolutionRun2020](http://bit.ly/ResolutionRun2020) ("Registration Form") and be the first one thousand (1,000) to answer the three (3) questions listed below:
  - i. Besides Malaysia, Sun Life Resolution Run is held in which country below? ("Question 1")
  - ii. Who is Sun Life Malaysia's Brand Ambassador? ("Question 2")
  - iii. "It would be an awesome experience to run my Resolution in \_\_ because \_\_ (max 15 words) ("Question 3")
- C. Valid Contest submissions require all three (3) questions (listed above) to be answered.

### 4. JUDGING CRITERIA

Entries will be judged based on the correct answers for Question 1 and Question 2 as well as creativity for Question 3.

Failure to answer Question 1 and Question 2 correctly will result in immediate Contest disqualification and ineligibility.

## 5. PRIZES

Two (2) winners will win an all-expense paid trip to the Resolution Run of their choice at Hong Kong, Philippines or Vietnam ("Prize"). Each winner will be eligible to bring along One (1) companion ("Winners' Companion").

One (1) winner will be chosen among the Participants who is not the Company's employee and one (1) winner will be chosen among the Participants who is the Company's employee as of 17 November 2019.

Expenses borne by the Company cover the following only:

- Return (two-way) Economy flight tickets for two (2) people per winner only. Airline will be chosen by the Company.
- Hotel accommodation of two (2) days one (1) night standard room (twin occupancy) for two (2) people per winner only. Hotel will be chosen by the Company.
- Sun Life Resolution Run registration fees (option of 5km or 10km) at location of choice for two (2) people per winner only.

The location of the Resolution Run will be predetermined by the winners' answer for Question 3. The Company will not entertain any request for a change of the location from the selected winners.

The Prize is non-exchangeable, non-transferable, and is not redeemable for cash or credit of any kind or other prizes.

The Company reserves the right to substitute the Prize with item(s) of equivalent value at any time without prior notice.

## 6. WINNERS

Winners will be notified by the Company at the end of the Contest Period, by 2<sup>nd</sup> December 2019, via the registered email listed in their Registration Form. If a winner cannot be contacted within five (5) working days of being notified by the means stated above, at the absolute discretion of the Company, the winner will be disqualified from winning the Prize and another Participant with the next accurate and creative submission will be selected by the Company as the winner. This selection process will be repeated until a winner is successfully contacted.

The Company shall not be held liable in any manner whatsoever to the Participants for any loss or damages howsoever arising in connection with the Contest (including loss of opportunity and consequential loss flowing therefrom) and damage suffered in the event the winner cannot be reached. Furthermore, the Company shall not be liable for any default in respect of the Contest due to any act of God, war, riot, strike, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of the Company.
