## Terms and Conditions

### The Contest Period

#SunnyMomentsContest ("Contest") is organised by Sun Life Malaysia Assurance Berhad and Sun Life Malaysia Takaful Berhad ("Company") from 12 January 2020, 5.00am to 13 January 2020, 11.59pm ("Contest Period").

### Eligibility
