SUPPORTING DOCUMENTS REQUIRED

Hospital Benefit/Hospital and Surgical Claim

- 1. Duly completed <u>Hospital & Surgical Claim Form</u>,
- 2. Duly completed <u>Hospital & Surgical Claim Form</u> by doctor on page 2-3,
- 3. Hospital discharge note/Summary providing the date of admission, date of discharge and diagnosis by doctor,
- 4. Copy of all relevant investigation results, hospital reports, CT/MRI Scan, X-ray report and etc,
- Copy of policy/contract/certificate documents, (If policy/contract/certificate document cannot be located, please complete Indemnity Form for Loss/Non-Receipt of Policy/Contract/Certificate Document),
- 6. Original hospital bills and receipts,
- 7. Copy of claimant's identity card/birth certificate/passport,
- 8. Certified true copy of claimant's bank passbook/statement.

<u>Loss of Income/Weekly Indemnity/Snatch Theft Claim (for Takaful Enhanced Disability - TEDPA claim only)</u>

- 1. Duly completed Comprehensive Accidental Benefit Claim Form,
- Duly completed <u>Comprehensive Accidental Benefit Claim Form</u> by doctor on page 3-5,
- 3. Certified true copy of police report, (* For TEDPA claims, the **original** police report is required),

- 4. Copy of medical leave certificate,
- Copy of policy/contract/certificate documents, (If policy/contract/certificate document cannot be located, please complete <u>Indemnity Form for Loss/Non-Receipt of Policy/Contract/Certificate Document)</u>,
- Original bill and receipts,
- 7. Copy of salary slip (only applicable to Livelife series),
- 8. Copy of claimant's identity card/birth certificate/passport,
- 9. Certified true copy of claimant's bank passbook/statement.

<u>Child Birth Claim (First Born) / Marriage Benefit Claim (First Legal Marriage)</u>

- 1. Duly completed Hospital & Surgical Claim Form,
- 2. Certified true copy of marriage certificate,
- 3. Certified true copy of birth certificate of child,
- 4. Copy of policy/contract/certificate documents, (If policy/contract/certificate document cannot be located, please complete Indemnity Form for Loss/Non-Receipt of Policy/Contract/Certificate Document),
- 5. Copy of policy/contract/certificate owner/holder's identity card/passport,
- 6. Copy of claimant's identity card/birth certificate/passport,
- 7. Certified true copy of claimant's bank passbook/statement.
