## **FUND MANAGER'S COMMENTS**

The Fund fell 6.73% during the month, outperforming the benchmark by 1.27ppt.

Global equities collectively advanced in the fourth quarter of 2022 as gains in October and November more than offset losses in December. However, as the quarter wound down, areturn of investor concerns about slower global economic growth driven by the aggressive rate-hiking actions of many central banks led global equities to retreat; they closed 2022 withtheir worst annual loss since the 2008 global financial crisis. The ongoing Russia-Ukraine war and a COVID-19 surge in China after the country's easing of its zero-COVID policy alsoweighed on investor sentiment.

While economic doldrums or recession would have a negative impact on enterprise software, hardware capital expenditures and IT services, we think the market's digestion of "pullforward" spending that occurred in 2021 and 2022 could exacerbate the pace of deceleration in 2023 and perhaps impact 2024 as well. We expect this situation to be less impactful to "platform" businesses that provide essential functionality and clear productivity benefits. We continue to believe digital transformation (DT) is a multi-trillion-dollar opportunity as itenables a widening array of companies to leverage software and data to better understand their customer and business processes, as well as various technologies to radicallytransform how they operate.
