FUND MANAGER'S COMMENTS

- With the persistently high inflation readings, the Fed changed its stance from neutral to outright hawkish in the last two FOMC meeting. In the past couple of months, implied expectations for Fed tightening have shifted from 2x25bps to 5x25bps rate increases by year-end 2022. The FOMC has given a clear hint that rate lift off will come in March, with the possibility of back-to-back rate increases in the next few meetings.
- Together with the January FOMC statement, the Fed also released the Principles for Reducing the Size of the Fed Reserve's Balance Sheet, which indicates that Quantitative Tightening will happen in a predictable manner through adjustment to the reinvestments of principals. UST rose as markets priced in the hawkish Federal Reserve.
- The People's Bank of China ("PBoC") said it was cutting the borrowing costs of its medium-term loans to cushion any economic slowdown. This is the first rate cut on policy loans by the PBoC since April 2020.
- Consumer prices in Singapore rose more than forecast to an eight-year high last month, increasing expectations its central bank will tighten policy prompting the government to review its inflation forecast. Headline inflation jumped by 4% from a year ago.
- Bank Indonesia kept the seven-day reverse repurchase rate at a record-low 3.5% though its Governor said BI will start raising reserve requirement ratio, hiking it to 5% in March with additional increases to come. Bank of Korea meanwhile signaled the likelihood of more interest rate increases to come following January policy rate hike to 1.25%.

STRATEGY:

- The global economy is currently at mid-cycle adjustment. The supply chain disruption has caused inflation to be "transitory" for longer. As central banks look to hike aggressively to tame inflation, our view is that the overall setback to global bond yields is still contained as expectations had been front loaded, while the Omicron surge proves to be more challenging for growth recovery.
- Remain cautious on Chinese HY properties names and prudent on credit selection in light of the negative headlines. The Fund currently has about 5% invested in the Chinese HY space. The Fund also has around 7% weight in Chinese government bonds and banks due to the different interest rate cycle.
- Cash level is at about 9% now, with the Fund intending to stay defensive in 1Q22. As such, duration has been shortened to 4 years. The current fixed income yield is at 5.2%. The breakdown of IG versus HY and unrated bonds remains at around 60% and 12% respectively.

RISKS

Market risk

Any adverse situations faced by the issuer may impact the value as well as liquidity of the Investment. In the case of rated investment, this may lead to a credit downgrade. Default risk relates to the risk of an issuer of the Investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the Investment. This could adversely affect the value of the target fund.

Interest rate risk

This risk refers to the impact of interest rate changes on the valuation of bonds or money market instruments ("Investment"). When interest rates rise, the investment prices generally decline and this may lower the market value of the Investment. The reverse may apply when interest rates fall.

Currency risk

As the Investments of the target fund may be denominated in currencies other than the base currency, any fluctuation in the exchange rate between the base currency and the currencies in which the investments are denominated may have an impact on the value of these investments. Investors should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.

Currency risk at the target fund level

The impact of the exchange rate movement between the base currency of the target fund and the currency of the underlying investments may result in a depreciation of the value of the investments as expressed in the base currency of the target fund.

Structured products risk

This in turn may cause the NAV of the target fund or prices of units to fall.

Regulatory risk

The investments of the target fund would be exposed to changes in the laws and regulations in the countries the target fund is invested in. These regulatory changes pose a risk to the target fund as it may materially impact the investments of the target fund. In an effort to manage and mitigate such risk, the fund manager seeks to continuously keep abreast of regulatory developments (for example, by closely monitoring announcements on regulators' website and mainstream media) in that country. The fund manager may dispose its investments in that particular country should the regulatory changes adversely impact the investors' interest or diminish returns to the target fund.
