#### **FUND MANAGER'S COMMENTS**

During the month, the Fund returned +1.89% in MYR terms, trailing the benchmark by 92 basis points (bps) mainly due to China. Year-to-date, the Fund declined -13.99%, underperforming the benchmark by 138bps.

As the Fed continues to tighten its monetary policy, most Asian central banks would have to follow a similar path or risk weakness in their currencies. The resultant economic growth path in reaction to the rate hike cycle would be keenly watched. The inflation trajectory would be the key determinant for the Fed's ability to slow down its pace of rate hikes or even reverse course depending on the extent of the economic and/ or financial markets slowdown. Recent commentary from Fed Chair, Jerome Powell suggested of slowing the pace of rate increases provided a relief to investors.

During the month, China faced escalating boycotts on mortgage payments. Separately a recent politburo statement removed any mention of economic goals, suggesting the government is downplaying the 5.5% GDP growth target and devoid of large infrastructure spending. We remain stock selective in China, favoring sectors that have secular tailwinds such as electric vehicles, renewables or innovators that continue to gain market share.

We remain fully invested and diversified across sectors and geographies. During the month we trimmed economic sensitive stocks in advertising and stocks related to the China property sector, while adding renewables and India consumer with increasing expectations that margin pressures are behind us.

Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments. Note: Please note that although Sukuk is a non-interest bearing instrument, its price movement is correlated to the movement in the interest rates. As such, investment in Sukuk will have an exposure to the movement of the interest rate referred herein is to the general interest rate of the country, which may affect the value of the investment of the target fund.
Risk associated with investing in CIS	Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
