## **PERFORMANCE RECORD**

This fund feeds into Principal Islamic Deposit Fund ("target fund") with the objective to provide investors with liquidity and regular income, while maintaining capital stability by investing primarily in Islamic deposit placements with licensed Islamic financial institutions that comply with Shariah principles.

#### **FUND MANAGER'S COMMENTS**

The Fund delivered 0.16% in the month of July 2022, underperforming the benchmark by 3bps, and delivered 1.69% in the 12-months period ending 29 July 2022, underperforming the benchmark by 13bps.

Bank Negara Malaysia ("BNM") increased the Overnight Policy Rate ("OPR") by 25bps from 2.00% to 2.25% at its July meeting. This is the second time BNM has increased the OPR this year. In its statement, it is mentioned that amid the growth prospects for the Malaysian economy, BNM decided to further adjust the degree of monetary accommodation, consistent in its view that the unprecedented conditions that necessitated a historically low OPR have continued to recede.

However, BNM highlighted that downside risks to growth continue to stem from a weaker-than-expected global growth, further escalation of geopolitical conflicts and worsening supply chain disruptions suggesting any adjustments to the OPR moving forward will be done in a measured and gradual manner.

Headline inflation continued to rise further for the third consecutive month to 3.4% YoY in June 2022 from 2.8% in May (market consensus: 3.2%). The increase was led by sustained price increases in most key sectors with the biggest increase seen in the food category. Food and non-alcoholic beverages went up by 6.1% YoY in June from 5.2% in May. Core inflation up by 3.0% in June as compared to 2.4% in the previous month.

We limit our investment exposure to short-term deposit placements due to the very low risk nature of the Fund.
