PERFORMANCE RECORD

FUND MANAGER'S COMMENTS

The Fund was down 5.23% in MYR terms in June, underperforming the benchmark by 586 bps. YTD, the Fund is down 8.79%, underperforming the benchmark by 1268 bps.

The MSCI AC Asia Pacific ex Japan Index fell by 6.3% in USD terms, led by Korea and Taiwan. Concerns over global recession and persistent inflation weighed on markets. Key issues for the market are (1) will there be a US recession and how deep will it be; (2) will inflation peak but stay elevated for longer; and (3) when will China recover. The US Federal Reserve remains steadfast in heading off inflation tightening monetary conditions, as evidenced in the 75bps hike mid June. With most of Asia also experiencing higher inflation, with the exception of China, Asian central banks will also have to tighten monetary conditions. India, Philippines are the countries most vulnerable to the negative impact. While inflation is expected to remain high in the next 3-6 months due to rising energy and food prices, we look out for peaking of inflation to be more positive on equities. The Caixin Composite PMI showed improvement in June, rebounding to 55.3 from 42.2 in May, as the movement restrictions eased. Year to date, fixed asset investment in China grew 6.2% yoy, better than expected. The Chinese government is likely to implement more fiscal policies to boost the economic growth after the lockdowns. We added our exposure to China selectively, with a preference over beneficiaries of decarbonization, reopening plays, winners of policy easing/fiscal stimulus etc. The rising commodities and inflationary environment and knock-on effect on demand remain the key risks to Asian corporate earnings. Nevertheless, we expect Asia to print positive earnings growth in 2022 given the reopening of the economies and international borders. We have a slightly positive view on Asian equities. We will also continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures. On a country basis, we prefer North Asia, Australia and Singapore.

Liquidity risk	Liquidity risk refers to the ease of liquidating an asset depending on the asset's volume traded in the market. If the target fund holds assets that are illiquid, or are difficult to dispose of, the value of the target fund will be negatively affected when it has to sell such assets at unfavourable prices.
Currency risk	As the investments of the target fund may be denominated in currencies other than the base currency of the target fund, any fluctuation in the exchange rate between the base currency of the target fund and the currencies in which the investments are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the investment.
Credit and default risk	The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in debt securities, money market instruments and/or place deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated debt securities, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. Principal (S) aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

RISKS (CONTINUED)

Interest rate risk

Interest rate risk refers to the impact of interest rate changes on the valuation of debt securities. When interest rates rise, debt securities prices generally decline and this may lower the market value of the target fund's investment in debt securities. In managing the debt portfolio, Principal (S) takes into account the coupon rate and time to maturity of the debt securities with an aim to mitigate the interest rate risk.

Risk associated with investing in CIS

Since the target fund may invest entirely into CIS, there is a risk of concentration into CIS, in which the CIS's management company has absolute discretion over the CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the CIS and/or the management company, the NAV of the target fund, which invests into those CIS would be affected negatively. Should the situation arise, Principal (S) will seek for another CIS that is consistent with the objective of the target fund.

Risk of investing in emerging markets

In comparison with investments in the developed markets, investment in emerging markets may involve a higher degree of risk due to the greater possibility of political or economic instability and societal tensions. Emerging markets are markets that are, by definition, "in a state of transition" and are therefore exposed to rapid political change and economic declines.
