FUND MANAGER'S COMMENTS

The Fund was down 7.12% in MYR terms in June, outperforming the benchmark by 36bps. YTD, the Fund is down 15.70%, underperforming the benchmark by 153bps.

Developed markets had another volatile month on recession concerns. S&P 500 Index, MSCI Europe and MSCI Japan was down -8.3%, -7.7% and -2.7% MTD in local currency terms. The US Dollar continued to strengthen by 2.9%, with Euro and Japanese Yen depreciating by 2.3% and 5.5%, respectively.

The decline for manufacturing PMI accelerated for all developed markets as production and new orders fell on weak demand. US consumer sentiment continued to fall on concernsabout inflationary pressure and weak economic outlook. Headline PCE continued to rise to record highs even though core PCE moderate slightly for US. Europe starts to see corporateearnings downgrades with forward 12m corporate earnings revised down by 0.8%. US earnings estimates are up 0.9%. Japan corporate earnings are estimated to increase by 1.4% inlocal currency term. But the positive earnings revisions mainly come from Energy and Materials Sector for US. As economy continue to slowdown, forward earnings would continue tobe revised down.

We maintain neutral allocations to all developed markets as we expect to see continued headwinds for equity markets going forward: 1) concerns on global growth slowdown; 2) broad-based persistent inflation, central banks monetary tightening and a potential policy mistake by the US Fed; 3) conflict between Ukraine and Russia; and 4) weak demand from Chinaand fears on renewed lockdowns. We think all these headwinds and lack of growth drivers would continue to weigh on markets in the short-term. Our underlying funds have focused oninvesting in quality companies with earnings visibility, at reasonable valuation.
