## PERFORMANCE RECORD

This fund feeds into Principal Islamic Deposit Fund ("target fund") with the objective to provide investors with liquidity and regular income, while maintaining capital stability by investing primarily in Islamic deposit placements with licensed Islamic financial institutions that comply with Shariah principles.

#### **FUND MANAGER'S COMMENTS**

The Fund delivered 0.14% in the month of June 2022, underperforming the benchmark by 2bps, and delivered 1.65% in the 12-months period ending 30 June 2022, underperforming the benchmark by 13bps.

Headline inflation rose 2.8% YoY in the month of May 2022 (Apr 2022: 2.3%) surpassing Bloomberg's consensus of 2.7%. Core inflation rose to 2.4% (Apr 2022:2.1%). Food and non-alcoholic beverages increased by 5.2% YoY, the highest level seen since 2012. In the month of May, 67% of 12 CPI components recorded a larger annual gain (i.e. including transport, recreation services and culture, restaurants and hotels).

Trade performance remained resilient in May 2022 as it rose 33.6% YoY to RM228.4 billion as exports grew 30.5% YoY and imports grew 37.3% to RM107.88 billion while trade surplus contracted by 8.2% to RM12.6 billion. Export growth was driven by higher demand for electrical and electronic (E&E) products, petroleum products, palm oil and palm oil-based agriculture products.

S&P revised Malaysia's rating outlook back to stable from negative while reaffirming the rating at A-. This comes after two years of negative outlook which has been in place since June 2020. The key rationales for the outlook change include strong economic recovery, expectation of medium-term growth prospects which are better than peers at the same income level and a continuation of strong external position and monetary policy flexibility.

We limit our investment exposure to short-term deposit placements due to the very low risk nature of the Fund.
