PERFORMANCE RECORD

FUND MANAGER'S COMMENTS

The Fund fell 7.88% during the month, outperforming the benchmark by 1.13ppts.

MSCI AC Asia ex Japan Islamic Index fell 9.0% in US\$ terms in June 2022, led by Korea and Taiwan as the US Fed tightened the policy rate by 75 percentage points, its third this year and bringing cumulative hikes thus far to 1.5%. Most equity markets posted negative returns except for China. The US 10-year bond yield reached a peak of 3.5% during the month before falling back down to 3.0% on increasing recessionary concerns.

As the Fed continues to tighten its monetary policy, most Asian central banks would have to follow a similar path or risk weakness in their currencies. The resultant economic growth path in reaction to the rate hike cycle would be keenly watched. The inflation trajectory would be the key determinant for the Fed's ability to slow down its pace of rate hikes or even reverse course depending on the extent of the economic and/ or financial markets slowdown.

Despite the situation being fluid, China continues to reopen with its latest move being to reduce quarantine times for inbound travellers by half. We continue to view that China will balance the need to control the Covid situation without imposing drastic measures such as that observed in Shanghai in the first half this year. We are incrementally turning more positive on China but remain stock selective. Overall we are also turning slightly more positive in Asian equities.

If this occurs, Principal will take the necessary steps to dispose of such securities. Shariah status risk There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall. Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and Risk associated with management. In the event of mismanagement of the Islamic CIS and/or the management investing in Islamic CIS company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund. The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, **Country risk** social and political stability, laws and regulations and foreign investments policies. These

factors may have an adverse impact on the price of the Islamic CIS, which will depress the

Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.
