#### **PERFORMANCE RECORD**

#### **FUND MANAGER'S COMMENTS**

The Fund declined 1.48% in MYR terms in March, outperforming the benchmark by 40 basis points (bps) mainly due to Australia. Year-to-date the Fund declined 7.40% in MYR terms, underperforming the Benchmark by 157bps.

The equity market correction in March was led by China while Australia and India outperformed. Geopolitical tensions and elevated inflation weighed on investors' sentiment. Commodity prices across the board continued to rise with Brent oil fluctuating from US\$129/ barrel at the height to US\$108/ barrel towards month end. The US-10 year bond yield rose meaningfully to 2.34% during the month. Beyond the Russia-Ukraine conflict, we expect the focus to return to the elevated inflation print across many countries and central banks' response in the months ahead. The near term inflation print will be complicated by the supply side impact on various commodities especially energy from the Ukrainian invasion. The trajectory of inflation and resultant bond yields from here-on would be a key indicator of any reversion in investor appetite.

We are fully invested and plan to diversify our holdings across businesses and geographies to improve our portfolio's resilience.

Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.
Risk associated with investing in CIS	Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
