PERFORMANCE RECORD

FUND MANAGER'S COMMENTS

For the month, the fund declined -0.68% in MYR terms, outperforming the benchmark by 10bps. The decline of the month was driven by Consumer Staples and Materials.

FBMKLCI lost -1.9% driven by Plantations, Healthcare and Property. Bank Negara maintained GDP growth forecast to 5.3-6-3% for 2022. Despite the re-opening of borders and businesses following the lifting of Covid-19 restrictions, the central bank expects some impact from the Russia-Ukraine conflict. BNM raised OPR by 25bps to 2.00% in the recent MPC meeting. Despite May's sell-off, valuation has not turned overly compelling considering its proximity to the historical 10-year mean PE of 16.5x.

We continue to adopt a balanced approach between value and growth, whilst maintaining adequate diversification. We are still overweight cyclical themes such as Consumer Discretionary. We continue to expect the market to trade sideways and see rotation from leaders to laggards.

Asia: The MSCI AC Asia Pacific ex Japan Index was flat last month in USD terms. China and Taiwan outperformed while the laggards were Korea and India. The US 10-year bond yield dipped 9bps to 2.84% during the month. China has been hit hard economically by lockdowns in various cities over the past few months, but it appears now that the authorities are starting to ease mobility restrictions with Covid daily infection numbers declining. The US Federal Reserve remains steadfast in heading off inflation tightening monetary conditions.

We have a slightly positive view on Asian equities. We favor adding Chinese equities as the country emerges from lockdowns coupled with economic stimulus. We will also continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures.

| Interest rate risk | Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments. |
| Country risk | Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall. |
