FUND MANAGER'S COMMENTS

The Fund was up 0.84% in MYR terms in May, underperforming the benchmark by 25bps. YTD, the Fund is down 9.23%, underperforming the benchmark by 200bps.

Developed markets had another volatile month ending flat for S&P 500 Index (-0.38%), MSCI Europe (+0.69%) and MSCI Japan (+0.93%) MTD in local currency terms. The US Dollar came off from peak weakened by 2% and Euro strengthened. Japanese Yen stabilized at 128-130 range. US 10-year bond yield came down to 2.93% at the time of writing. The Fed balance sheet reduction will start in June with a monthly cap of \$47.5m for treasuries, agency debt and MBS before increasing to \$95m after 3 months.

US manufacturing PMI slowed on cooling demand, material shortages and delivery delays. Inflation cost continued to accelerate. Business confidence declined to lowest level since October 2020. US consumer sentiment also declined on inflation concerns. However, employment is still strong with better-than-expected nonfarm payrolls in May. Europe PMI declined on weaker demand and high inflation. Japan PMI was unchanged from the previous month, but firms are increasing hiring as the backlog of work accelerated. On the other hand, forward 12m corporate earnings are revised up for all developed markets, led by Europe. But the positive earnings revisions mainly come from Energy and Materials sectors.

As geopolitical tensions and supply disruptions may continue to put upward pressure on commodity prices, inflation may continue to be a concern. Potential risks to economy may also come from the pace of monetary tightening and potential policy mistake. We have added commodity and energy exposure to hedge inflation risk. Overall, we maintain neutral allocations to all markets as we expect the issues of when inflation would moderate, the pace of its moderation, the Fed's tightening path and geopolitical tensions to weigh on markets in the short-term.
