#### **FUND MANAGER'S COMMENTS**

The Fund rose 2.29% during the month, underperforming the benchmark by 5.33ppt.

After a rocky start to the month, global equities collectively posted gains for October 2022 despite investor concerns about a global economic slowdown, the escalating Russia-Ukrainewar, persistently high inflation in multiple regions and broadly tighter monetary policy. Many central banks continued their hawkish monetary policy stance to fight inflation, thoughinvestor optimism returned that the US Federal Reserve (Fed) would slow the pace of its policy tightening following an expected rate increase in early November.

In our view, inflation, increased interest rates, and increased equity capital costs are the primary near-term risks in the IT and communication services sectors. Looking further ahead to2023 and beyond, we continue to believe DT is a multi-trillion-dollar opportunity as it enables a widening array of companies to leverage software and data to better understand their customer and business processes, as well as various technologies to radically transform how they operate.
