PERFORMANCE RECORD

This fund feeds into Principal Islamic Deposit Fund ("target fund") with the objective to provide investors with liquidity and regular income, while maintaining capital stability by investing primarily in Islamic deposit placements with licensed Islamic financial institutions that comply with Shariah principles.

FUND MANAGER'S COMMENTS

The Fund delivered 0.21% in the month of October 2022, in line with the benchmark and delivered 1.57% in the 12-months period ending 31 October 2022 which was underperforming the benchmark by 12bps.

Malaysia's inflation rate was recorded at 4.5% YoY in September, moderating from the 4.7% YoY recorded in August. The moderation in inflation was attributed to the food group which moderated to 6.8% compared with 7.2% in August.

Malaysia's trade continued its upward trajectory in September rising by 31.4% YoY. Exports increased by 30.1% YoY while imports expanded by 33% YoY. Trade in 3Q2022 surged by 42% YoY to RM774.98 billion. On a MoM basis, exports increased by 2.2% and the trade surplus rose 86.1%, while trade contracted by 3.2% and imports shrank by 9.4%.

Budget 2023 was tabled on 7 October followed by the dissolution of the Parliament on 10 October 2022. Following that, the 15th General Elections was announced to be held on 19 November with nomination day to be on 5 November.

Budget 2023 was mildly expansionary as it proposed a total expenditure of RM372.3 billion, higher than the proposed RM332 billion for Budget 2022. The proposed spending for 2023 is nevertheless lower than the estimated spending of RM385.3 billion where the latter included the Covid fund. There was an increase in development expenditure to RM95 billion from RM76 billion. A lower fiscal deficit target is set for 2023 at 5.5% of GDP (2022: 5.8% of GDP (revised) vs. 6.0% budgeted). The target is higher than previously guided under MTFF Budget 2022.

We limit our investment exposure to short-term deposit placements due to the very low risk nature of the Fund.
