PERFORMANCE RECORD

This fund feeds into Principal Islamic Balanced Wholesale Fund-of-Funds ("target fund") with the objective to achieve moderate capital growth by investing in a portfolio of Shariah-compliant collective investment schemes that invest in Shariah-compliant equities and/or Sukuk.

FUND MANAGER'S COMMENTS

The Fund rose 0.89% during the month, underperforming the benchmark by 0.89ppt.

MSCI AC Asia ex Japan Islamic Index rose 0.8% in US\$ terms in October with top performers being South Korea, Malaysia, India and Australia while China was a major detractor. Sentiment deteriorated post the China congress due to the lack of representation of more market-oriented leaders in the Politburo. The US 10-year bond yield rose 22bps to 4.05% while the Dollar Index decline 0.5% during the month. Crude oil rebounded 7.8% to US\$94.80 per barrel after OPEC+ made a decision to cut production by 2 million barrels per day.

As the Fed continues to tighten its monetary policy, most Asian central banks would have to follow a similar path or risk a depreciation in their currencies. The resultant economic growth reaction to the rate hike cycle would be keenly watched. The futures market is currently implying a further 180bps rate hike up till March 2023 and thereafter to decline. Much of its trajectory would depend on the inflation rate or whether there will be any unintended consequences to the economy/ financial markets in order for the Fed to change its course.

Post the China congress meeting, we are now looking out for clarity on wide-ranging policies especially with regards to its approach towards zero-Covid for economic repair. Forward risks include path of monetary policy normalization led by the US Fed and reaction from Asian central banks, as well as Russia-Ukraine escalation and US-China tensions which can range from various sanctions, financial markets such as Chinese listings in the US, military conflicts etc.

Market risk

For example, investment decisions undertaken by Principal, as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error or weaknesses in operational process and systems, may adversely affect the performance of the target fund.

Reclassification of Shariah status risk

This risk refers to the risk that the currently held Shariah-compliant securities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the securities by the Shariah Advisory Council of the Securities Commission Malaysia (SACSC), Shariah adviser of the issuer, the Shariah Adviser or the Shariah boards of the relevant Islamic indices. If this occurs, Principal will take the necessary steps to dispose of such securities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall.

Risk associated with investing in Islamic CIS

Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.

Country risk

The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, social and political stability, laws and regulations and foreign investments policies. These factors may have an adverse impact on the price of the Islamic CIS, which will depress the Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.

Currency risk

As the target fund may invest into Islamic CIS denominated in currencies other than MYR, any fluctuation in the exchange rate between MYR and the currencies in which the Islamic CIS are denominated may have an impact on the value of these investments. You should be aware that if the currencies in which the Islamic CIS are denominated depreciate against MYR, this will have an adverse effect on the NAV of the target fund in MYR and vice versa. You should note that any gains or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the target fund.
