FUND MANAGER'S COMMENTS

- Global equities rose in October, rebounding from falls earlier in the year as third-quarter earnings proved more resilient than expected and investor hopes of a slower pace of monetary tightening rose. However, weak results from major technology companies indicated a slowing economic landscape. While corporate results so far have been mixed, particularly for major technology names, stocks rose in the US, Europe, UK and developed Asia.
- Individual stock contributions of note included Lululemon. It won its dismissal of Peloton's lawsuit over athletic wear. Brokers subsequently published positive notes. Lululemon is considered one of the highest quality global athleisure brands. It continues to gain market share and has scope to continue growing revenues whilst expanding margins. Atlas Copco delivered strong third quarter results supported by demand for compressors giving investors greater confidence that earnings will prove resilient through the weaker economic environment. Emerson Electric announced the sale of it Climate Technologies business to Blackstone and announced full year results. Its shares reacted positively to both.
- On the negative side, Asian Paints fell despite delivering strong revenue growth. Margins came in lower than expected due to higher input costs. Its plans for backward integration and setting up joint ventures for raw materials should enhance its competitive position. China Resources Land was also among the laggards. Weakness across the Chinese property sector has affected its shares. Its contracted sales increased 37% in October but full year sales remain behind. Manhattan Associates reported results which were ahead of market estimates and performed well operationally. However, investors were concerned with management's forward guide, which was in line with expectations for revenues but weaker on margins.
- There were no strategic trades over the month.

| External Investment Manager Risk | The fund management function of the target fund is delegated to Aberdeen Asset Managers Limited ("AAML"). AAML ("External Investment Manager") is an entity within the Aberdeen Standard Investments group ("ASI Group"). Although the External Investment Manager is an entity within the ASI Group and they will have regular meetings with Aberdeen Standard to deliberate on the investment themes and portfolio decisions, there is still the risk that the External Investment Manager may not adhere to the investment mandate of the target fund due to an oversight. | Market risk | Market risk refers to potential losses that may arise from changes in the market prices of the Shariah-compliant equities that the target fund invests in. This risk is mitigated through the diversification process that Aberdeen Standard will employ in the management of the target fund whereby the target fund will hold a diversified portfolio of Shariah-compliant equities across various sectors and countries. | | |
| Shariah-compliant warrants risk | The price, performance and liquidity of Shariah-compliant warrants are typically linked to the underlying Shariah-compliant equities and therefore subject to those risks. However, the price, performance and liquidity of such Shariah-compliant warrants will generally fluctuate more than the underlying Shariah-compliant equities because of the greater volatility of the warrants market. | Currency risk | As the investments of the target fund may be denominated in currencies other than the base currency, any fluctuation in the exchange rate between the base currency and the currencies in which the investments are denominated may have an impact on the value of these investments. | Reclassification of Shariah status risk | This risk refers to the risk that the currently held Shariah-compliant equities in the target fund may be reclassified as Shariah non-compliant in the periodic review of the equities by the Shariah Advisory Council of the Securities Commission (SACSC), the Shariah Adviser or the Shariah Boards of the relevant Islamic indices. If this occurs, Aberdeen Standard and the External Investment Manager will take the necessary steps to dispose of such equities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess capital gains derived from the disposal of the Shariah non-compliant equities. Aberdeen Standard and the External Investment Manager will be required to dispose of these equities immediately if the market price is above the investment cost. Should the market price be below the investment cost, Aberdeen Standard and the External Investment Cost. Nevertheless, should Aberdeen Standard and the External Investment Manager decide to dispose of these equities below the investment cost, the target fund will be faced with the risk of realising its losses, thus negatively impacting the NAV of the target fund. |
