FUND MANAGER'S COMMENTS

For the month, the fund declined -1.75% in MYR terms, underperforming the benchmark by -102bps. The underperformance of the month was driven by Financials, Communication Services and Utilities.

FBMKLCI was down just marginally -0.5%. Commodities, Telcos and Consumer Discretionary outperformed. Malaysia's PMI reading for April was 48.8 pts, similar to March. However, there were some positive signs with regards to new export orders. No change to BNM's GDP growth of 4-5% in 2023. BNM raised OPR by 25bps to 3.00% in the latest MPC meeting and economists are still expecting another 25bps hike for the rest of the year. Malaysia's equity market valuations remain extremely compressed with forward PE of under 13x still at over -2SD below the historical mean.

Despite domestic fundamentals and valuations remains positive, we are cautious on near term given the global risk events. Thus, we prefer to be defensive and have adopted a barbell approach between value and growth. In terms of sectors, we prefer domestic driven sectors such as Consumer Discretionary and Utilities which deemed as more defensive in nature among the sectors while we continue to like structural growth themes in selective Technology. In view of stronger rebound in tourist arrivals post reopening, we also like tourism related stocks.

The MSCI AC Asia Pacific ex Japan Index fell 1.8% in USD terms in April 2023. Indonesia and India were among the best performing markets while China and Taiwan ROC lagged. The US 10-year bond yield ended the month almost flat, and the Dollar Index declined by 0.8%. China's GDP growth in the 1Q23 was better than expected, growing at 4.5% YoY. The services PMI in April remained above 50 but manufacturing PMI has fallen below 50. The April Politburo meeting addressed the sustainability of the recovery as it noted that the domestic demand is still weak. Hence, we should continue to expect the government to roll out targeted measures to boost demand and maintain its pro-business and pro-growth stance. We remain selective in our stock selection in China.

We have a positive view on Asian equities, as China economy recovers and valuations are slightly attractive. We will continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures.

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.
