#### **PERFORMANCE RECORD**

The Fund feeds into AHAM Select Asia (ex Japan) Quantum Fund ("target fund") with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

#### **FUND MANAGER'S COMMENTS**

- US equities advanced cautiously in April amidst fractures in the banking sector and concerns over the US government's debt ceiling. The S&P 500 rose 1.50% as investors heaved a sigh of relief over the emergency rescue of First Republic Bank. In an emergency government-led intervention, JPMorgan will take over First Republic's assets to stave off a broader banking crisis in the financial system.
- In Asia, the broader MSCI Asia ex-Japan index closed 2.20% lower in April dragged down by losses in China and Taiwan. Despite stronger than expected economic growth, the MSCI China index fell 5.20% as simmering US-China tensions weakened sentiment. According to Financial Times, Washington had asked South Korea to urge its chipmakers to hold back from boosting sales to China if Micron is banned as a result of an investigation by Beijing.
- Skepticism over China's long-term growth prospects and whether its recovery has further legs were also concerns raised amongst European money managers in a survey by Bank of America. Without the presence of global long-only investors, we have seen sharp erratic moves in China's equity market due to the presence of hedge funds and speculative capital flows.
- Meanwhile, major chipmaker Samsung Electronics said that it would make a "meaningful" cut to chip production after reporting a plunge in its quarterly results amidst a downturn in the industry. In prior downcycles, the company had only announced a reduction in capex as opposed to a full-blown production cut. This augurs well for the semiconductor space which could find a quicker recovery as supply normalizes.

#### STRATEGY:

- The probability of a sharper slowdown in US has risen on the back of tighter financial conditions. We are mindful that this presents downside risk to Asia as well, despite relatively stronger growth expectations.
- The Fund remains overweighted in China and Hong Kong market. Over the month, raised cash from 6% to 8%.
- We exited a position in a Chinese toll road operator given elevated capex requirement, a position in a US-listed business process outsourcing service provider, and a position in a leading Indonesian fashion retailer. Added to existing position in a Chinese sportwear brand and a Chinese innovative medical device manufacturer.
- The fund maintains its position in the China Reopening Play and structural growth theme across other Asia regions.

#### **RISKS**

Market risk

Interest rate risk

**Country risk**

This in turn may cause the NAV of the target fund or prices of units to fall.

### **Currency risk**
