#### FUND MANAGER'S COMMENTS

During the month, our Fund declined 0.12% in MYR terms, underperforming the benchmark by 155 basis points (bps) due to China and India. Year-to-date our Fund rose by 3.46%, underperforming the benchmark by 145bps.

As we approach the peak of monetary policy tightening in the US with less inflationary concerns and signs of stress in the banking system (i.e. regional banks), Asian equities should be reasonably well supported. The futures market is now implying a modest 25bps rate hike in the Fed's upcoming meetings in May/ June and thereafter ~2 rate cuts by yearend. We maintain our view that Asian equities will be supported by China's reopening, bottoming of the tech hardware cycle and undemanding valuations. China is in its early days of recovery and patience is needed to see through its near term weakness. Certain signs such as selected Internet companies' more growth-oriented strategy and restructuring are early indicators that private sector "animal spirits" are returning. We prefer domestic oriented companies that are more insulated from potential global demand weakness or geopolitical factors. Meanwhile in tech hardware, more commentaries from market leaders point towards a demand recovery in 2H23 and in certain instances, some willingness to curb supply side production and capex in order to support pricing.

With the economic repair in China and bottoming of the technology hardware cycle in Korea/ Taiwan, we are positive on Asian equities. During the month, we added Indian auto, global tech equipment and Hong Kong SAR property names at the expense of stocks where catalysts are lacking. Risks are (a) US banking sector-spill over to the economy, (b) weaker property markets in China could affect consumer confidence and weaken fiscal conditions in poorer regions, and (c) geopolitical tensions between US and China could escalate.

You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund in the base currency of the target fund and vice versa. <b>Credit/Default risk</b>	The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in Sukuk and/or place Islamic deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. This could adversely affect the value of the target fund. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

**Interest rate risk**

Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.

Note: Please note that although Sukuk is a non-interest bearing instrument, its price movement is correlated to the movement in the interest rates. As such, investment in Sukuk will have an exposure to the movement of the interest rates. Even though the target fund does not invest in interest bearing instruments, the interest rate referred herein is to the general interest rate of the country, which may affect the value of the investment of the target fund.

**Risk associated with investing in CIS**

Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
