FUND MANAGER'S COMMENTS

- The fund performance was 1.3% during the month, outperforming the benchmark by 1.0%.
- December was a strong month for global fixed income, after US Treasuries rallied following the revised Dot Plot. Key
 highlights from the statement and press conference include strongest signal that rates have peaked, and the dot plot
 pointed to multiple rate cuts in 2024.
- US inflation continued to show signs of easing, with inflation data lower than the previous month, but still some distance from the Federal Reserve's 2% target. Economic data released during the month was mixed but reaffirmed expectations of a soft landing for the economy. As a result, the US Treasury 10-year yields rallied to 4.25% (-43bps) during the month.
- In line with US, inflation data for Asian countries are also expected to ease in 2024. Property downturn to remain as main drag on China's economy in 2024.
- Malaysia's fixed income market also experienced a positive month. The demand for local bonds especially for long duration was seen with the yield curve bull flatten during the month. The yields for 3-year, 10-year, and 30-year MGS ended the month at 3.47% (-1bps), 3.73% (-10bps) and 4.25% (-6bps) respectively.

STRATEGY:

- Concerns over inflation has subsided although it is still above Fed's 2% target. The market pricing for US Fed Fund Rate has shifted lower with the revision of the latest FOMC's dot plot.
- Domestically, the moderating growth and subdued inflation continued to be supportive of the fixed income market. The lower government bond supply profile in 2024 due to fiscal consolidation is also a positive factor to the market. The domestic liquidity is ample with demand from duration coming from pension funds and lifers.
- Prefer belly to long tenor government bonds and continue to selectively participate in primary corporate bond/sukuk
 issuances for yield pick-up, subject to levels. Taking profit on shorter dated papers and re-investing in longer duration
 bonds. Continue to favour BBB rated bond within IG space, which offers better valuation as compared to other IG
 ratings.
- Smaller exposure to HY bonds as a slowdown in global growth could lead to more liquidity and credit rating downgrades. Close to zero exposure in China property sector as recovery expected to be slow despite policy support. Exited position in Australia energy space to take profit.
- Positioning in selective government bonds across tenors. Continue to participate in MYR primaries due to attractive yield offering.
