#### **PERFORMANCE RECORD**

This fund feeds into Nomura Global Shariah Sustainable Equity Fund - MYR Class A ("target fund") with the objective to achieve long-term capital growth.

#### FUND MANAGER'S COMMENTS

After a strong November, global developed equity markets extended their gains in the first half of December before trading activities tapered off as approaching the end of 2023. Global Shariah Sustainable Equity Fund MYR Class A managed to deliver +2.55 return for the month. But, it underperformed the benchmark by 103bps as market sided on the risk-off mode where low quality companies and laggards outperformed.

By region, North America was the main drag due to selection. A slightly higher cash level remained a drag on a performing market. By sector, allocation was a positive with no exposure in Energy and overweight in Industrials. This is offset by selection in IT and Healthcare.

The top contributors to performance were Pentair PLC and ASML. On the other hand, the top detractors to performance were Adobe and SAP. In the latest earnings release, Adobe guided Digital Media net new ARR at \$1.9B which missed the street consensus at \$2.0B. In addition, Adobe and Figma entered into a mutual agreement to abandon the \$20B acquisition deal by Adobe mainly due to regulatory pressure. While Figma could be a new competitor down the road, we believe that Adobe is equipped with strong monetization capabilities as a SaaS via Firefly, a generative AI product that was unveiled in March 2023.

#### Impact focus of the month:

Over the past two years, the team have engaged extensively with Thermo Fisher Scientific's management on the sale of DNA sequencing devices and consumables within the People's Republic of China. The company has engaged proactively on this issue and has now announced that it has halted sales in the regions associated with potential human rights violations. The original allegations of malpractice related to the province of Xinjiang and predated our initial investment. In 2019, Thermo Fisher halted sales of DNA sequencing devices in Xinjiang after it was alleged that the Chinese authorities were using them to build genetic surveillance infrastructure to monitor the Uyghur minority living in the province. Even after sales were officially stopped, the team were concerned that controls were not sufficient and devices were being transferred to Xinjiang from other provinces in China. Engagements with Thermo Fisher supported the view that the company was taking steps to address this and that prior sales volumes in Xinjiang were not sufficient to amount to mass genetic surveillance. In 2022, new concerns emerged around Thermo Fisher's equipment being used in the mass collection of DNA by the Tibetan authorities. The team's engagement with Thermo Fisher resumed focussed around pushing for a halt in sales to the province similar to Xinjiang. Pressure from activists and lawmakers as well as investors seems to have helped persuade the company, and in January 2024 Thermo Fisher confirmed that they had stopped selling DNA technology in the Tibet region.
