#### FUND MANAGER'S COMMENTS

During the month, the Fund increased by 3.44% in MYR terms, outperforming the benchmark by 39 basis points (bps) mainly due to China and Taiwan.

With bulk of monetary policy tightening being implemented in 2022, we are near the last leg of rate hike increases. The Fed dot plot suggests a rate of 5.125% by end 2023 vs the current midpoint of 4.625% suggesting only minor increases going forward. Much of the policy rate trajectory would depend on the inflation rate, which has started to come in lower than expected in its recent data.

Post the Congress meeting, China has surprised the market in the speed it is reopening the economy and its intention to turnaround the property and internet sectors. We favour reopening plays in China and where valuations still look attractive despite the 3-month rally in Chinese equities. The risks include (a) will stimulative policies be sufficient to turn around the sectors which had been hard hit; (b) to what extend will corporates e.g. in internet be able to normalize their business activities; (c) monetary policy path; and (d) geopolitics e.g.US-China tensions which can range from various sanctions, financial markets such as Chinese listings in the US, military conflicts, etc.

We remain fully invested. With a weakened US\$, economic repair in China and bottoming of the technology hardware cycle in Korea/ Taiwan, we are positive on Asian equities. During the month, we added more consumer discretionary and property related names in China / HK SAR at the expense of more defensive stocks. We also added selected names in India which are exposed to a potential rural recovery.

Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.
