FUND MANAGER'S COMMENTS

The Fund increased by 10.81% during the month, outperforming the benchmark by 0.72ppt.

Global equities rallied in January as better-than-feared corporate earnings reports, stronger-than-expected economic data in certain regions and China's economic reopening bolsteredinvestor sentiment. Additionally, moderating inflation in the United States, the eurozone and the United Kingdom led many investors to expect a continued deceleration in interest-ratehikes.

We continue to believe DT is a multi-trillion-dollar opportunity as it enables a widening array of companies to leverage software and data to better understand their customer andbusiness processes, as well as various technologies to radically transform how they operate. Furthermore, with evidence that DT drives improved productivity and deeper customerrelationships, we believe companies are now operationalising and scaling what worked during the COVID crisis and extending their DT initiatives into other parts of their operations.
