#### FUND MANAGER'S COMMENTS

During the month, the Fund increased by 3.47% in MYR terms, outperforming the benchmark by 42 basis points (bps) mainly due to China and Taiwan.

With bulk of monetary policy tightening being implemented in 2022, we are near the last leg of rate hike increases. The Fed dot plot suggests a rate of 5.125% by end 2023 vs the current midpoint of 4.625% suggesting only minor increases going forward. Much of the policy rate trajectory would depend on the inflation rate, which has started to come in lower than expected in its recent data.

Post the Congress meeting, China has surprised the market in the speed it is reopening the economy and its intention to turnaround the property and internet sectors. We favour reopening plays in China and where valuations still look attractive despite the 3-month rally in Chinese equities. The risks include (a) will stimulative policies be sufficient to turn around the sectors which had been hard hit; (b) to what extent will corporates e.g. in internet be able to normalize their business activities; (c) monetary policy path; and (d) geopolitics e.g. US-China tensions which can range from various sanctions, financial markets such as Chinese listings in the US, military conflicts, etc.

We remain fully invested. With a weakened US\$, economic repair in China and bottoming of the technology hardware cycle in Korea/ Taiwan, we are positive on Asian equities. During the month, we added more consumer discretionary and property related names in China / HK SAR at the expense of more defensive stocks. We also added selected names in India which are exposed to a potential rural recovery.

You should be aware that if the currencies in which the investments are denominated depreciate against the base currency of the target fund, this will have an adverse effect on the NAV of the target fund in the base currency of the target fund and vice versa. <b>Risks associated with investment in warrants and/or options</b>	There are inherent risks associated with investment in warrants and/or options. <b>Credit/Default risk</b>	The target fund will be exposed to a certain degree of credit and default risk of issuers or counterparties when the target fund invests in Sukuk and/or place Islamic deposits. Credit risk relates to the creditworthiness of the securities issuers or counterparties and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuers or counterparties may impact the value as well as liquidity of the investments. In the case of rated Sukuk, this may lead to a credit downgrade. Default risk relates to the risk that a securities issuer or counterparty either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investments. This could adversely affect the value of the target fund. Principal aims to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

**Interest rate risk**

Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and Islamic money market instruments. When interest rates rise, Sukuk and Islamic money market instruments' prices generally decline and this may lower the market and Islamic money market instruments. In managing the Sukuk, Principal takes into account the coupon rate and time to maturity of the Sukuk with an aim to mitigate the interest rate risk. As for Islamic money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike Sukuk, any change to interest rate will only have a minor impact to the prices of these instruments.

Note: Please note that although Sukuk is a non-interest bearing instrument, its price movement is correlated to the movement in the interest rates. As such, investment in Sukuk will have an exposure to the movement of the interest rates. Even though the target fund does not invest in interest bearing instruments, the interest rate referred herein is to the general interest rate of the country, which may affect the value of the investment of the target fund.

**Risk associated with investing in CIS**

Since the target fund may invest into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and management. In the event of mismanagement of the Islamic CIS and/or the management company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.
