PERFORMANCE RECORD

This fund feeds into Principal Islamic Balanced Wholesale Fund-of-Funds ("target fund") with the objective to achieve moderate capital growth by investing in a portfolio of Shariah-compliant collective investment schemes that invest in Shariah-compliant equities and/or Sukuk.

FUND MANAGER'S COMMENTS

The Fund rose 1.12% during the month, underperforming the benchmark by 4 bps.

MSCI AC Asia ex Japan Islamic Index rose 6.4% in USD terms in January led by a China, Australia, Korea and Taiwan while India and ASEAN were laggards. Sentiment continued to improve with further relaxation of China's Covid zero measures and better inflation footprint in the US.

With bulk of monetary policy tightening being implemented in 2022, we are near the last leg of rate hike increases. The Fed dot plot suggests a rate of 5.125% by end 2023 vs the current midpoint of 4.625% suggesting only minor increases going forward. Much of the policy rate trajectory would depend on the inflation rate, which has started to come in lower than expected in its recent data.

Post the Congress meeting, China has surprised the market in the speed it is reopening the economy and its intention to turnaround the property and internet sectors. We favour reopening plays in China and where valuations still look attractive despite the 3-month rally in Chinese equities. Risks include (a) will stimulative policies be sufficient to turnaround the sectors which had been hard hit; and (b) to what extend will corporates e.g. in internet be able to normalize their business activities.

If this occurs, Principal will take the necessary steps to dispose of such securities. There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event that the Shariah non-compliant securities are disposed of at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund or price of units to fall. Since the target fund will invest entirely into Islamic CIS, there is a risk of concentration into Islamic CIS, in which the Islamic CIS's management company has absolute discretion over the Islamic CIS's investment technique and knowledge, operational controls and Risk associated with management. In the event of mismanagement of the Islamic CIS and/or the management investing in Islamic CIS company, the NAV of the target fund, which invests into those Islamic CIS would be affected negatively. Should the situation arise, Principal will seek for another Islamic CIS that is consistent with the objective of the target fund.

Country risk

The target fund may invest into Islamic CIS which can be domiciled in various countries. Therefore, the target fund will be subjected to risks specific to the countries in which the Islamic CIS are domiciled. Such risks include adverse changes in economic fundamentals, social and political stability, laws and regulations and foreign investments policies. These factors may have an adverse impact on the price of the Islamic CIS, which will depress the Islamic CIS's NAV growth, and consequently depress the target fund's NAV growth.

Currency risk

As the target fund may invest into Islamic CIS denominated in currencies other than MYR, any fluctuation in the exchange rate between MYR and the currencies in which the Islamic CIS are denominated may have an impact on the value of these investments.
