#### **FUND MANAGER'S COMMENTS**

The Fund rose by 5.82% during the month, underperforming the benchmark by 0.36ppt.

Global equities collectively rose during the second quarter of 2023 as concerns about the banking industry subsided, the US debt ceiling issue was resolved, many companies' first-quarter earnings exceeded consensus estimates, and investors welcomed several central banks' slower pace or pausing of interest-rate hikes. However, concerns remained that persistent inflation combined with robust labour markets in many regions could lead their central banks to further tighten monetary policy and hurt economic growth. Global growthstocks, led by technology-related companies, significantly outperformed global value stocks. After a brief bout of weakness in April, global information technology (IT) and communication services sector stocks were outliers to the upside in May, while all nine other sectors sold off.

We continue to believe "Digital Transformation" (DT) is a multi-trillion-dollar opportunity as it enables a widening array of companies to leverage software and data to better understandtheir customers and business processes, as well as various technologies to radically transform how they operate. Furthermore, with evidence that DT drives improved productivity anddeeper customer relationships, we believe companies are now operationalising and scaling what worked during the COVID crisis and extending their DT initiatives into other parts of their operations.

In our long-term view, the most important aspect is still "quality," which we define as companies with strong, improving competitive positions, experienced/talented management teamswith a proven track record of execution, premium-level financial strength and strong unit economics—along with an awareness about the costs they are imposing on the environmentand society, adding to signs that an appropriate corporate governance structure is in place.
