FUND MANAGER'S COMMENTS

For the month, the fund rose +0.98% in MYR terms, outperforming the benchmark by +96bps. The outperformance of the month was driven by Communication Services, Health Care and Consumer Discretionary.

FBMKLCI fell over 2%. Weakness was in line with the sell-off in regional markets as investors aggressively risked off following the collapse of several high-profile banks in the US and Europe. Market however rebounded towards the later part of the month, as fears of a banking contagion was easing. Financials and Commodities were sold down in favor of defensive sectors such as Healthcare and Utilities during the month. BNM now projects Malaysia's GDP growth to moderate from 8.7% in 2022 to 4-5% in 2023 (from 4.5% previously), due to the slowdown in global growth on the back of persistent pressures from inflation and tightening of global financial conditions, in addition to a high base effect. Malaysia's equity market valuations remain extremely compressed with forward PE of under 13x still at over -2SD below the historical mean.

We remain positive for the market as Malaysia is expected to continue benefitting from robust domestic economic activity, further buoyed by China's recovery. We favour domestic driven sectors such as Consumer Discretionary, Industrials and Utilities. We also prefer selective Technology for structural growth as well as Gloves for emerging values. Key risks are derailment of Malaysia's macro recovery and corporate earnings growth due to a larger-than-expected impact of rising inflation, slower global economic growth as well as heightened geopolitical risks.

The MSCI AC Asia Pacific ex Japan Index rebounded by 2.45% in USD terms. Singapore and China were among the best performing markets while Australia and Malaysia lagged. The US 10-year bond yield fell 45bps to 3.47% after the fallout of Silicon Valley Bank and run on US regional banks and the Dollar Index declined by 2.3% during the month. China's COVID, economic and regulatory policies are coordinated in favour of growth for the first time in 3 years. Policy mode is shifting toward a focus on economic development after the Two Sessions. There are signs of sustained recovery in China, with property sector stabilizing and China PMIs remaining above 50. We expect the broad economic indicators to improve further in 2023.

We have a positive view on Asian equities, as China economy recovers and valuations are attractive. We will continue to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those with pricing power to overcome cost pressures.

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.
