FUND MANAGER'S COMMENTS

For the month, the fund rose +0.40% in MYR terms, outperforming the benchmark by +39bps. The outperformance of the month was driven by Health Care, Materials and Real Estate.

FBMKLCI lost 2%. The sell-off was relatively broad-based, accompanied with the recent weakness of the Ringgit. Malaysia's PMI reading for May was 47.8pts vs 48.8 pts in April. According to S&P Global, respondents often cited weak demand leading them to scale back purchasing as well as staffing. BNM raised OPR by 25bps to 3.00% in the last MPC meeting.

We prefer to maintain a cautious stance and continue to adopt a barbell strategy, balancing between value and growth, though we are saw opportunity on selective sectors post the recent market sell-down. We are constructive on domestic-driven sectors, such as Utilities and REITS, while we continue to like structural growth themes in selective Technology. Furthermore, in view of a stronger rebound in tourist arrivals post-reopening in China, we also like airport and tourism-related stocks.

The MSCI AC Asia Pacific ex Japan Index fell 2.65% in USD terms in May 2023. Taiwan ROC and Korea were among the best performing markets while China and Hong Kong lagged. The US 10-year bond yield ended the month at 3.64%, up 22bps and the Dollar Index appreciated by 2.62%.

The April jobs report in the US showed a very strong increase in non-farm payrolls. The US headline CPI, however, continues to moderate, sitting at 4.9% YoY in April. This may lend support to a pause in rate hike by the US Fed. The recovery in China is uneven led by services while manufacturing lags. We are selective in our stock selection, minimizing exposure to geopolitical risks or slower than anticipated recovery in domestic demand.

We have a positive view on Asian equities given attractive investment themes and corporates have the potential to post better earnings growth than developed markets. We willcontinue diversify the portfolio and to focus on quality companies which have good earnings visibility, robust balance sheet, long term winners, market share gainers and those withpricing power to overcome cost pressures.

Stock specific risk

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.

Interest rate risk

Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.

Country risk

Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

Currency risk
