FUND MANAGER'S COMMENTS

Equity

Weak selection in industrials and materials was offset by selection in information technology, health care and consumer discretionary. On a regional basis, weak stock selection in Japan and United Kingdom was partially offset by selection in Emerging Markets and Developed EU & Middle East ex UK. Within communication services and information technology, our top relative contributors were overweights to Alphabet and Advanced Micro Devices, respectively. Within industrials and materials, our top relative detractors were overweights to TechnoPro Holdings and FMC, respectively. Shares of Alphabet surged after the company made several AI announcements at its I/O developer conference, including "AI Snapshot", which integrates generative AI results directly on top of Google's search results, and the incorporation of generative AI capabilities across its product suite. The stock benefitted further from news that Samsung would not replace Google with Bing as the default search engine on its smartphones. Shares of TechnoPro Holdings ended the period lower after the technology-focused staffing and services company reported third quarter operating income at the end of April that missed analyst expectations. Management cited higher bonus related payments in addition to costs as a result of delays between hiring and deployment of less experience hires due to training as drivers of lower margins compared to 3Q22.

Sukuk

Overall, the sukuk sleeves underperformed benchmark at 1.38, driven by corporate and industrial sectors. Sa Global Sukuk Lt 06/2031 was the main contributor whereas Maf Sukuk Ltd 05/2029 was the main detractor. We maintain our strategy in defensive position while ensure desirable return to the portfolio. Our credit exposure where GCC region accounted by 49.03%, Saudi Arabia (SA) (23.17%), United Arab Emirates (UAE) (21.05%), Qatar (3.46%) and Kuwait (1.35%). Our exposures in Malaysia and Indonesia are 35.79% and 15.17% respectively.
