FUND MANAGER'S COMMENTS

Equity

Strong selection in health care and consumer staples was partially offset by selection in industrials, materials and real estate. On a regional basis, strong stock selection in North America was partially offset by selection in Emerging Markets and Japan. Within health care and consumer staples, our top relative contributors were overweights to AstraZeneca and Unilever, respectively. Within industrials and materials, our top relative detractors were overweights to TechnoPro Holdings and FMC, respectively. AstraZeneca shares rose during the period. AstraZeneca subsidiary Alexion will acquire a portfolio of rare disease gene therapy programs and technologies from Pfizer for \$1 billion, enhancing their genomic medicine capabilities. AstraZeneca also reported positive clinical trial results for drugs Fasenra for eosinophilic granulomatosis with polyangiitis, Enhertu for lung cancer, and Tagrisso plus chemotherapy for lung cancer. Shares of TechnoPro Holdings ended the period lower after the company reported mixed Q4 earnings in August. Operating profit exceeded the initial forecast but fell short the full year guidance due to upfront investment in aggressive hiring and extensive training to keep up with robust demand from customers.

Sukuk

The sukuk sleeves outperform its benchmark by 24bps (Sukuk Return: -0.80 vs Benchmark: -1.04), driven by industrial sector (Fund: -0.96 vs Benchmark: -1.61). Names such as MAF Sukuk Ltd (UAE) and BEWG (M) Sdn Bhd (MYR) contributed positively to the sukuk sleeves outperformance. The detractors meanwhile arising from our investment in Government Nationals sector (Fund: -1.03 vs Benchmark: 0.00).

There may be opportunity loss to the target fund due to the target fund not being allowed to retain the excess gains derived from the disposal of the Shariah non-compliant securities. In the event the Shariah non-compliant securities are disposed at a price lower than the investment cost, it may adversely affect the value of the target fund. Thus, it may cause the NAV of the target fund to fall.
Credit and Default Risk	Credit risk relates to the creditworthiness of the issuers of Sukuk, Islamic money market instruments and/or financial institutions where the Islamic deposits are placed and their expected ability to make timely payment of profit and/or principal. Any adverse situations faced by the issuer of the Sukuk, Islamic money market instruments and /or financial institutions where the Islamic deposits are placed may impact the value as well as liquidity of the Sukuk, Islamic money market instruments and/or Islamic deposits. Interest Rate Risk	the target fund. Interest rate risk refers to the impact of interest rate changes on the valuation of Sukuk and/or Islamic money market instruments. When interest rates rise, Sukuk and/or Islamic money market instruments prices generally decline and this may lower the market value of the target fund's investment in Sukuk and/or Islamic money market instruments. The reverse may apply when interest rates fall. Meanwhile, Sukuk and/or Islamic money market instruments with longer maturities and lower profit rates are more sensitive to interest rate changes.
