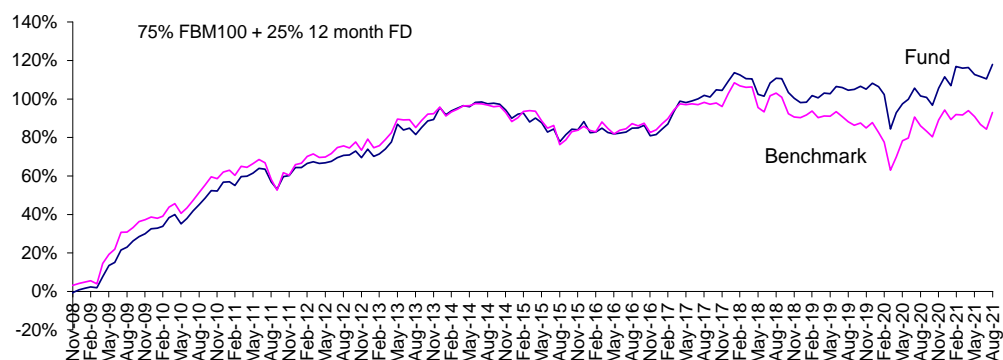

FUND MANAGER'S COMMENTS

In August 2021, the Fund's performance increased by 3.54%, underperforming the benchmark by 1.14%.

FBMKLCI rose 106pts or 7% to 1,601.38pts in August, a level not seen since June before the whole domestic political debacle started and it was the best monthly performance in over a decade. Although Plantations stocks led the pack, reopening plays, dominated by large-caps, were in focus - Transport (+6%), Finance (+6%), Industrials (+6%) and Consumer (4%).

Malaysia's manufacturing PMI rose further to 43.4pts in August from 40.1pts in July - the manufacturing sector remained weak, albeit improving. Businesses reported reductions in both production levels and new orders as rise in COVID-19 cases hampered output and sales, however, easing lockdown measures helped take some of the pressure off. On a positive note, expectations for the coming year have improved as more companies grew optimistic that the worst of the pandemic has passed.

MoF released the pre-budget statement recently with some highlights being the lowering of 2021 GDP growth to 3%-4% following BNM's estimate. They also project fiscal deficit to be between 6.5%-7% of GDP in 2021. Statutory debt to GDP ratio is expected to rise by end of the year following higher borrowings and GDP growth downgrade. The economy grew 16.1% YoY in 2Q21 (1Q21: -0.5%), compared with 2020 when a strict MCO was first imposed. CPI eased to 2.2% YoY in July-21 after a 3.4% YoY increase in June-21, mainly due the normalization of the low base effect. YTD July-21, CPI increased by 2.3% YoY. On 22 August, DS Ismail Sabri was sworn in as the 9th Prime Minister of Malaysia after TS Muhyiddin Yassin stepped down a week prior after losing majority support in Parliament. Prior to the new appointment, he remained as caretaker PM for the country. A new cabinet was then unveiled on 27 Aug 2021, with the new cabinet largely consisting of mostly the same people with some reshuffling of portfolios seen. Excluding Ismail Sabri, there were only five new ministers while 16 were retained in the same portfolio and another 10 were reshuffled.

For MYR fixed income strategy, we do not expect any change to the interest rates at the upcoming MPC meeting on 9 September. We believe interest rates will continue to remain accommodative in the near to medium term. We are seeing improvement in local bond market sentiment following the appointment of our new PM and the unveiling of the new cabinet. Additionally, ample domestic liquidity is seen following the maturities seen for the period and as such, believe the local bond market will remain supported.
