FUND MANAGER'S COMMENTS

For the month, the fund rose +3.00% in MYR terms, underperforming the benchmark by -39bps. The underperformance of the month was driven by Financials, Materials and Utilities.

FBMKLCI rose +7% in August, a level not seen since June before the whole domestic political debacle started. Although Plantations stocks led the pack, reopening plays, dominated by large-caps, were in focus - Transport, Finance, Industrials and Consumer.

Malaysia's manufacturing PMI rose further to 43.4pts in August from 40.1pts in July - the manufacturing sector remained weak. Valuations are approaching the 10-year historical mean, but appears to be well justified by strong corporate earnings growth, with an attractive dividend yield of almost 4%.

We turn positive on Malaysia as movement controls ease, paving way for a full reopening of the economy, and domestic political issues abating. We continue to be selective on stocks from a bottom-up basis that plays into the reopening theme and thus remain constructive on sectors such as Financial, cyclical themes namely Consumer Discretionary, Basic Materials and select Transport.

Asia: The MSCI AC Asia Pacific ex Japan Index rose 1.9% in USD terms in August, led by good performance in South East Asia and India.

China manufacturing PMI fell to 50.1 and service PMI slumped to 47.5 in August. In China, we expect more regulatory intervention in areas such as residential property in tandem with the country's Common Prosperity drive. However, we also believe that the government will implement targeted easing in its fiscal and monetary policies to support the economy. We maintain our view that fund flows are more likely to move to Asia since it is under-owned and valuation is more attractive compared to global equities.

We rate Asian equities a BUY over a 12-month horizon. We remain our focus on quality companies which are long term winners, or benefit from structural changes in their respective industries through market share gain. We also prefer companies with pricing power to overcome cost pressures and have been diversifying between growth stocks and those with improving fundamentals such as selective financials, materials, communication services and healthcare.

We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

Currency risk
