#### PERFORMANCE RECORD

The Fund feeds into Affin Hwang Select Asia (ex Japan) Quantum Fund ("target fund") with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

#### **FUND MANAGER'S COMMENTS**

- Global equities advanced in August despite taper talks by the US Federal Reserve. The Fed soothed market fears by asserting that the Fed will remain accommodative and not rush to raise rates. The MSCI AC World index was up 2.5% while the S&P 500 rose 3.0% in the month. US equities hit all-time highs buoyed by stimulus optimism
- The MSCI AC Asia ex-Japan index was up 2.3% even as regulatory headwinds continue to cloud North Asian markets. China passed a major data protection law setting out tougher rules on how companies collect and handle their users' information.
- Regulatory concerns continued to dominate as Chinese state media reported that gaming firms should no longer have the preferential tax measures previously introduced to encourage the development of the domestic software sector.
- Share price of luxury stocks and retailers in China fell on investors panic selling due to concerns that ultra-wealthy individuals may be targeted. This comes on the back of a recent policy meeting chaired by President Xi Jinping, in which he added that China must pursue "common prosperity" in which wealth is shared by all people.
- Some weakness was seen in the semiconductor space. The DRAM sector is seeing some softness amidst concerns that it has reached its cyclical top. Average selling prices growth is set to moderate as manufacturers turn cautious on demand. Tech-heavy markets including Taiwan and Korea saw some selling during the month.

#### STRATEGY:

- Valuations for Asian markets are now more palatable, and sentiments are less exuberant. However, regulatory risk in China and slowing economic and earnings growth could pose more downside risk in the near term. Tapering would be another risk we watch out for.
- Asian markets are expected to remain rangebound due to a lack of catalysts. The Chinese markets may continue to struggle due to tightening fears and regulatory overhang on the internet sector.
- The fund's invested level is now at 87%, as the fund reduced exposure to selected Chinese stocks due to regulatory risk. We continue to be on the lookout for structural growth names but the fund has a larger tilt towards value reopening and cyclical names for now.
- The fund exited a Chinese game development company due to increased regulatory risk. We added an Indonesian property developer, and several Taiwan companies including a café and bakery operator, an electronic product safety test service provider, and a contact lens OEM.
- Structural growth names and economic reopening themes make up bulk of the fund, while cyclicals exposure has increased to around 15% of the fund.

#### **RISKS**

Market risk

Interest rate risk

This risk refers to the impact of interest rate changes on the valuation of debentures or money market instruments (hereinafter referred to as "investment"). When interest rates rise, the investment prices generally decline and this may lower the market value of the investment. The reverse may apply when interest rates fall.

Warrants investment risk

The value of the warrants will depend on the pricing of the underlying security, whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. In addition, the value of the warrants may decrease exponentially as the warrants approach its maturity date and the potential gains from a favourable price movement of the underlying security may be offset by aggressive time decay. We may consider unwinding these warrants if there are material adverse changes to its value with the aim to mitigate the risk.

**Country risk** 

Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or prices of units to fall.

#### **RISKS (CONTINUED)**

### **Currency risk**
