#### **FUND MANAGER'S COMMENTS**

- UST traded range bound in August. UST 10Y was initially traded lower than 1.20% in the early part of the month before climbed following the robust July US nonfarm payrolls. However, yield eased back towards month end following dovish comment by Chair Powell during the Jackson Hole. He endorsed the now widely shared view that purchase reductions could be appropriate before the end of the year. His comments reflect a committee that is divided with a group of hawks seeing asset purchases as inappropriate for an economy facing supply-side constraints.
- It was a relatively firm month in the Asian Credit space with Asia IG and HY spreads seen tightening Company specific headlines were dominated by news surrounding China Evergrande.
- Chinese HY property names were up on average as valuations became more appealing after weeks of downtrend. Meanwhile, Macau gaming names traded weaker amid concerns over the resurgence in COVID-19 in the region.
- South Korea became the first major Asian economy to raise interest rate, with more hikes in the pipeline as its central bank indicated that financial risks pose a bigger threat to the economy than the latest virus outbreak. The Korean central bank said the quarter-percentage-point hike to 0.75% still left rates in an accommodative position that supports the economy.
- RBA said it will stick with its planned tapering of bond purchases, wagering that the economy will recover rapidly from a contraction this quarter driven by virus lockdowns. RBA also maintained the cash rate at 0.1% as had been widely expected.

#### STRATEGY:

- We view the room for global central banks to start hiking interest rates in the near term is still limited given the ongoing pandemic and uneven recovery. However, near term volatility could come from potential tapering by US Fed. There could be upward repricing risk in the UST yields if the Fed starts to taper in 4Q2021 and this will also impact the outlook for local bonds. However, we view that much of the big move had already taken place in the 1Q2021.
- Expect the lower for longer interest rates environment remains due to uneven and uncertain recovery post Covid-19 and abundant global liquidity.
- We remain cautious on Chinese HY properties names and will look to add on low beta names such as Shimao. We
  continue to favor quality names with a tilt towards the IG segment. The breakdown of IG versus HY and unrated bonds
  are 62% and 13% respectively. Focus will be on credit selection with government bonds to provide liquidity for trading
  opportunities.
- Cash level is at about 5% now. The fund positioning remains cautious with duration kept neutral. The current fixed income duration: 4.9 years while the fixed income yield is at 3.3%.

#### **RISKS**

#### Market risk

#### Interest rate risk

This risk refers to the impact of interest rate changes on the valuation of bonds or money market instruments ("Investment"). When interest rates rise, the investment prices generally decline and this may lower the market value of the Investment. The reverse may apply when interest rates fall.

#### **Currency risk**

As the Investments of the target fund may be denominated in currencies other than the base currency, any fluctuation in the exchange rate between the base currency and the currencies in which the investments are denominated may have an impact on the value of these investments. #### Currency risk at the target fund level

In an effort to manage and mitigate such risk, the fund manager seeks to continuously keep abreast of regulatory developments (for example, by closely monitoring announcements on regulators' website and mainstream media) in that country.
