#### FUND MANAGER'S COMMENTS

The Fund (Class MYR) rose by 3.38% during the month of October 2021, overperforming the benchmark by 26bps.

US and Europe markets rebounded in October on strong corporate earnings and solid economic momentum. S&P 500 and MSCI Europe increased by 7% and 4.7% respectively in local currency terms. On the other hand, MSCI Japan declined by 1.3% in JPY term following the election result of Fumio Kishida elected as the new LDP leader. Sentiment on Japan was also adversely impacted by concerns of sustained inflationary pressure. US 10-year bond yield increased to 1.521% at the time of writing. The Fed has announced its plan to unwind its monthly pandemic stimulus program. The US Dollar was flat MTD and Euro and Japanese Yen depreciated by 0.3% and 2.3% respectively.

We remain strategically positive on all developed markets moving to 2022. We think that developed economies growth is likely to stay resilient. Healthy household balance sheet, high savings rate, record high job openings and robust wage growth support consumption and demand growth. Looking into 2022, developed countries' GDP growth is likely to stay well above trend even if growth rate moderates. Although higher PPIs from China may pose a risk to global inflation being more persistent, we maintain our view that the high inflation is temporary in nature and do not expect inflation spiral out of control. As global COVID-19 situation continues to improve with vaccination rates going up and positive developments on COVID-19 treatment, economic activities would continue to normalize. Moving forward, equity markets will be supported by the positive earnings growth across all developed markets for 2022. We expect the Fed tapering to complete in mid-2022 and US economy should be strong enough for the US Fed to hike policy rate once in 2H22. Although there are some short-term volatilities, we maintain our positive view on all developed markets.
