FUND MANAGER'S COMMENTS

For the month, the fund declined -0.31% in MYR terms, outperforming the benchmark by +307bps. The outperformance of the month was driven by Health Care, Consumer Discretionary and Energy.

FBMKLCI lost 4% in September, spooked by a surprise move by the MOF seeking local banks to waive interest payments for loans under moratorium in 4Q21 for borrowers in the B50 category, and concerns that the government might be imposing more taxes to shore up revenues to fund stimulus measures.

Malaysia's manufacturing PMI rose further to 48.1pts in September from 43.4pts in August, suggesting that the weakness in the manufacturing sector has eased. Bank Negara maintained the OPR at 1.75% during the MPC meeting on 9 September. Valuations are approaching the 10-year historical mean, but appears to be well justified by strong corporate earnings growth, with an attractive dividend yield of almost 4%.

We remain positive on Malaysia as movement controls ease, paving way for a full reopening of the economy, and domestic political issues abating. We continue to be selective on stocks from a bottom-up basis that plays into the reopening theme and thus remain constructive on sectors such as Financial, cyclical themes such as Consumer Discretionary and select Transport. We continue to overweight selective Technology companies.

Asia: Review: The MSCI AC Asia Pacific ex Japan Index declined 4.3% in USD terms in September, led by poor performance in Thailand, Korea and China/Hong Kong SAR.

Globally, the softness in PMIs continued, but there was some sign of improvement in Asian countries recovering from the impact of the Delta variant. The power crunch in China is likely to last in the 4Q21, leading to rising PPI, GDP growth downgrade. Nevertheless, global economy should continue to recover in 2022 as spending on services increases. We maintain our view that fund flows are more likely to move to Asia since valuation is more attractive with relatively stronger earnings growth in 2022, compared to developed markets.

We are cautiously optimistic about Asian equities over a 12-month horizon. Maintain focus on quality companies which are long term winners, or benefit from structural changes in their respective industries through market share gain. We also prefer companies with pricing power to overcome cost pressures and quality growth companies.

Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.
