TERMS AND CONDITIONS**

GIVEAWAY PERIOD

Sun Life Malaysia Champion Your Brighter Side Facebook Live Session Giveaway ("Giveaway") is organised by Sun Life Malaysia Assurance Berhad Registration No: 199001005930 (197499-U) and Sun Life Malaysia Takaful Berhad Registration No: 200501012215 (689263-M) ("Company") from 5.00pm until 6.30pm on 6 February 2021 ("Giveaway Period").

ELIGIBILITY

- A. The Giveaway is only open to Malaysian citizens and Permanent Residents (PR) with Malaysia identification card, aged 18 and above who have registered to join the Sun Life Malaysia Champion Your Brighter Side Facebook Live Session ("Live Session") by registering at bit.ly/SLMFBLive and have stayed until the end of the Live Session ("Participants").

GIVEAWAY MECHANICS
