## **FUND MANAGER'S COMMENTS**

The month of August has been one of the strongest months for the local bond market in terms of performance with the bond market achieving close to 2% in a single month. However, we expect increasing volatility and some mild corrections in the short term. With that said, we expect yields to remain low and this may persist over the next year. Meanwhile, we expect duration extension to continue as more and more global sovereign bond yields are in negative territory. We have also seen strong demand for the recent 30-year MGS reopening with book-to-cover of 2.49x on issuance size of RM2 billion. As such, we maintain our duration call at 6.0 - 7.0 years while remaining invested in liquid papers where 25% - 35% will be invested in government and government guaranteed papers.
