

FUND MANAGER'S COMMENTS

Given that the fund will become a feeder fund starting from October, we have liquidated the majority of the portfolio by selling the stocks into August's market rally. From October onwards, the fund will feed directly into Affin-Hwang ALLMAN Growth fund where the investment objective and parameters remain the same.

On YTD basis, the fund continued to outperform its benchmark by 5.03%. The fund also outperformed its benchmark on 1-year and 3-year basis by 3.28% and 3.25% respectively.
