FUND MANAGER'S COMMENTS

With the US firmly on the path of rate hikes, we view that monetary policy in major economies is likely to remain divergent in the medium term. Despite fluctuating foreign demand for MGS, we have seen local institutional demand remain robust. With MGS yields remaining relatively low, we see further opportunities to invest in higher yielding government and high-grade corporate bonds. We also continue to seek opportunities to switch certain government securities and government-guaranteed bonds into more liquid and higher yielding high quality corporate Sukuk. We continue to target a duration of around 5-6 years.
