The Game Period

The Unlock The Luck, Collect The Huat Game ("**Game**") is organised by Sun Life Malaysia Assurance Berhad [Registration No.: 199001005930 (197499-U)] and Sun Life Malaysia Takaful Berhad [Registration No: 200501012215 (689263-M)] (hereinafter collectively referred to as the "**Company**") from 24 January 2022 till 12 February 2022, 11:59PM ("**Game Period**").

The Company may, at its sole and absolute discretion, extend or hold the Game Period at any time without prior notice.

Eligibility

The Game is only open to Malaysian citizens and Permanent Residents (PR) with a Malaysian identification card, aged 18 and above (the "**Participant(s)**").

The Company's employees, agents, suppliers, advertising agencies and their immediate family members are *not eligible* to participate in the Game.

Game Mechanics

The Game will be available on <u>www.Sunlifecollectthehuat.com</u> ("**Game Page**"). Any entries after the Game Period shall not be entertained.

The Participants are required to do the following to participate in the Game:
