

FUND MANAGER'S COMMENTS

The fund was fully liquidated in September and it has become a feeder fund from October 4th onwards. Due to the cash holding for the month, the fund's performance was flat but outperformed its benchmark by 0.72% as the broad market return was negative in September.

On YTD basis, the fund continued to outperform its benchmark by 5.73%. The fund also outperformed its benchmark on 1-year and 3-year basis by 1.10% and 4.43% respectively.
