

FUND MANAGER'S COMMENTS

For the month, the fund declined 380bps (basis points) in MYR terms, underperforming the benchmark by 304bps. Year to date, the fund is underperforming the index by 636bps.

The KLCI rose 1.8% in LCY but was up 4.6% in USD terms and outperformed MSCI ASEAN's +2% during the month. The index appears to have fully recovered from the "Liberation Day" sell-off. Investors sentiment was mainly buoyed by hopes of the US dialling back on tariffs against major trading nations, therefore easing concerns on the derailment of global trade and prospects of a recession. Gainers were led by Telcos, Consumer and Healthcare, while main laggards were Energy and Transport. Within the broader market, Tech continues to languish.

Other key benchmarks: CPO down 12% to c.RM3,900/t, Brent down 15% ~US\$63/bbl. Ringgit strengthened 3% against the Dollar at RM4.3158, while the 10Y MGS yields fell 11bps to 3.6570.

Malaysia's manufacturing sector moderated further in April, with a softer PMI reading of 48.6pts vs 48.8pts in the previous month. S&P Global stated that demand conditions remain subdued while firms opted to work through backlogs in the absence of new orders while also scaling back employment, purchases and stock holdings. Inflation pressure trended downwards once again in April but only mildly. Business confidence slipped to the lowest level since July 2023, with firms expressing concerns about the potential adverse impacts of muted global economy and US tariffs. The latest PMI data still suggests modest growth in GDP for 1Q25 – advanced estimates show MY GDP grew 4.4% in 1Q25. To recap, Malaysia's GDP grew by 5% in 4Q24 and 5.1% for 2024. BNM maintained its GDP growth forecast of 4.5-5.5% in 2025 during the recent briefing but highlighted potential risk to growth due to the trade restrictions.

BNM maintained OPR at 3.00% during the last MPC meeting and we expect the central bank to hold rates steady given muted inflation and modest economic growth. Inflation slowed to 1.4% in March, lower than the 1.5% in the previous month. There appears to be sufficient headroom to central bank's latest 2.0-3.5% CPI forecast for 2025 with the impending subsidy rationalization plans.

MSCI AC Asia Pacific ex Japan Index was slightly up in April, ending 1.86% higher. The index was held up by China, which returned 9.26% for the month, fuelled by an AI related rally. Apart from the tech sector, the Chinese markets have not seen that strong of a move. Valuations for the Chinese markets as a whole remain relatively cheap. Korea was the next best performer, ending up 5.08% for the month. The worst performing markets were Taiwan and Indonesia. Taiwan was down 12.94% for the month as the Taiwanese currency rallied almost 10% in the space of 2 trading days. This has pushed investors to be concerned on the earnings of export-oriented companies.

We have a positive view on Asian equities, given the attractive investment themes. We still like the tech sector as we see semiconductor investments continuing to grow into next year while expectations have been lowered. We will continue to diversify and position the portfolio in areas where they are likely to print strong earnings growth such as the semiconductor industry, beneficiaries of AI spend, and Korea value up program, rising consumer discretionary spent or rising capex. We have been taking some profits off from our China names as we see risk of disappointment in relation to stimulus going into 2025.

This could adversely affect the value of the target fund. We aim to mitigate this risk by performing bottom-up and top-down credit research and analysis to determine the creditworthiness of its issuers or counterparties, and impose investment limits on exposures for issuers or counterparties with different credit profiles as a precautionary step to limit any loss that may arise directly or indirectly as a result of a defaulted transaction.
Interest rate risk	Interest rate risk refers to the impact of interest rate changes on the valuation of debt instruments and money market instruments. When interest rates rise, debt instruments and money market instruments prices generally decline and this may lower the market value of the target fund's investment in debt instruments and money market instruments. In managing the debt instruments, we take into account the coupon rate and time to maturity of the debt instruments with an aim to mitigate the interest rate risk. As for money market instruments, the typical tenor of these instruments are less than 12-month maturity and unlike debt instrument, any change to interest rate will only have a minor impact to the prices of these instruments.
Country risk	Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or price of units to fall.

We attempt to mitigate these risks through active asset allocation management and diversification across different countries and sectors, in addition to our continuous bottom-up and top-down research and analysis.

The value of warrants is influenced by the current market price of the underlying security, the exercise price of the contract, the time to expiration of the contract and the estimate of the future volatility of the underlying security's price over the life of the contract. Generally, the erosion in value of warrants accelerates as it approaches its expiry date. Like securities, we will undertake fundamental research and analysis on these instruments with an aim to mitigate its risks.
