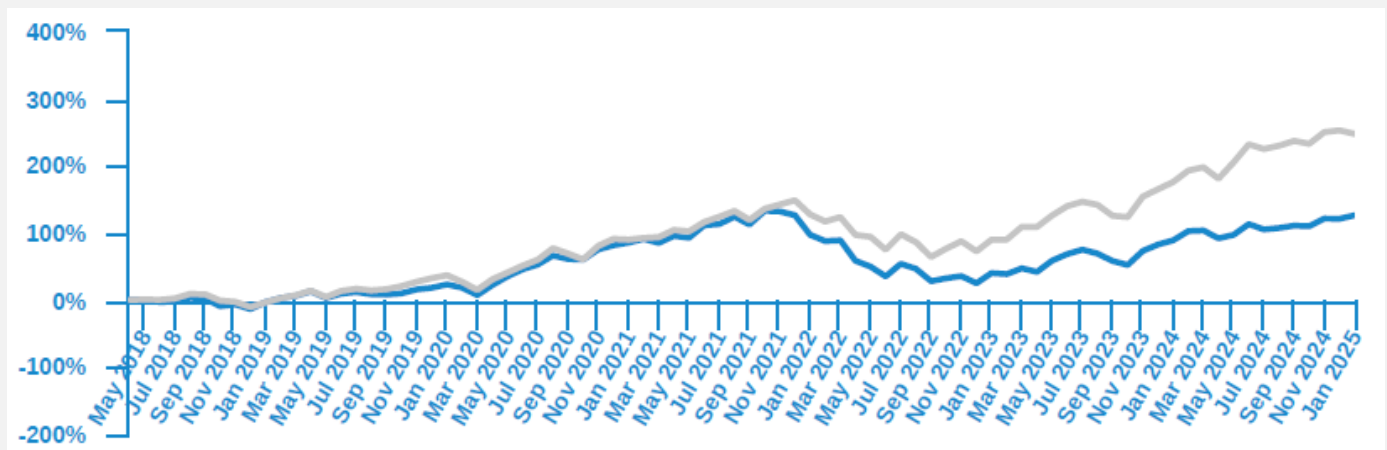

FUND MANAGER'S COMMENTS

The Fund rose 2.16% during the month, outperformed the benchmark by 3.65%.

The market in January faced concerns over U.S. trade policies and advancements in artificial intelligence, particularly with new AI models emerging from China. While the broader market showed resilience, the information technology sector lagged, primarily due to a selloff in AI-related stocks, tariff threats on semiconductor components, and stretched IT stock valuations. Despite these challenges, AI remains a major area of growth, with companies and investors optimistic about long-term returns. Infrastructure funding for AI and industry partnerships continue to drive the sector forward, emphasizing AI's transformative potential across industries.

Fund performance was largely influenced by sector allocation, with semiconductor holdings contributing to losses despite strong stock selection. Some key positions declined from record highs, while smartphone sales weakened in certain regions. On the other hand, cybersecurity and cloud infrastructure stocks remained strong amid increasing demand for AI computing. Challenges included trade frictions, semiconductor stock declines, and weakness in enterprise software, though some companies saw opportunities for future expansion. Overall, the report highlights AI-driven growth, ongoing trade risks, and the evolving technology landscape.
