PERFORMANCE RECORD


The Fund feeds into AHAM Select Asia (ex Japan) Quantum Fund ("target fund") with the objective of achieving capital appreciation over the medium to long-term by investing in Asia (ex Japan) equities with market capitalization of not more than USD1.5 billion at the time of investment. However, the target fund would also have an option to invest into companies with a market capitalization of not more than USD3.0 billion at the time of investment, which will be capped at no more than 30% of the Net Asset Value (NAV) of the target fund.

FUND MANAGER'S COMMENTS

- US equities surged in September, with the S&P 500 climbing 3.5% to a fresh all-time high following the Federal Reserve's (Fed) first rate cut of the year. The 25bps cut was widely anticipated, but the updated dot plot provided additional clarity, showing a median year-end forecast for the Fed funds rate of 3.6%, down from 3.9% in June.
- Interestingly, while the Fed lowered rates, it simultaneously revised up its GDP and inflation forecasts—underscoring the resilience of the US economy. This was reinforced by a series of stronger-than-expected data releases. US 2Q'2025 GDP growth was revised up to 3.8% from 3.3%, driven by robust consumer spending and steady business investment. Real personal consumption also rose 0.4% m-o-m, highlighting strength in household demand.
- In Asia, the MSCI Asia ex-Japan index rose 6.6% in September lifted by optimism over Fed rate cuts and prospects of a weaker US dollar. The MSCI China index surged 9.3% as trade tensions eased between US and China.
- Korea also posted strong gains, with the KOSPI rallying 7.5% on speculation of fresh policy support under President Lee Jae-myung. Marking his first 100 days in office, Lee pledged to usher in a "KOSPI 5,000" era, while actively engaging with brokers and industry players to explore measures to lift valuations.
- On the local front, the benchmark KLCI rose 2.3% in September. However, the index has continued to lag behind other market segments over the past 3 months, with the ACE Market up 15.7% and the small-cap index gaining 8.8%, compared with a 5.2% rise in the KLCI in the 3Q'2025.
- In the bond market, the 10-year Malaysian Government Securities (MGS) yield edged up 2 bps to 3.45%. As expected, Bank Negara Malaysia (BNM) kept the Overnight Policy Rate (OPR) unchanged at 2.75%. Recall that in July, BNM delivered a pre-emptive 25 bps cut to preserve growth prospects. The central bank has flagged downside risks from slower global trade, weaker sentiment, as well as lower-than-expected commodity production.

STRATEGY:

- The fund delivered returns of -0.50% (MYR) in Sept; underperforming its benchmark, the MSCI AC Asia ex Japan Small Cap index, which rose by +1.7% in MYR terms over the same period.
- The funds' relative underperformance was mostly due to our underweight position in Korea & Taiwan, where Tech Al upstream supply chain names continued to rally on the back of bullish capex spending guidance over the next 12-18 months by major Cloud Service Providers (CSP) during their 2Q results briefings.
- The funds' positions in Pharma & Healthcare names across Korea & India also dragged the fund as the latter's market continued to face liquidity outflows as foreign investors rotate to other regional markets given 3Q earnings are expected to remain soft in. Korean pharma names also dragged after President Trump's surprise 50-100% tariff announcements on imported, branded pharmaceutical products.
- Strategically, the fund slightly increased its weight into Malaysia from 20% to 30% at the expense of India. We also took some profit off the table from our Singapore positions as the positives have mostly been priced in.
- The fund remains highly invested with cash levels of around 2-3%.

Interest rate risk

This risk refers to the impact of interest rate changes on the valuation of debentures or money market instruments (hereinafter referred to as "investment"). When interest rates rise, the investment prices generally decline and this may lower the market value of the investment. The reverse may apply when interest rates fall.

Warrants investment risk

The value of the warrants will depend on the pricing of the underlying security, whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. In addition, the value of the warrants may decrease exponentially as the warrants approach its maturity date and the potential gains from a favourable price movement of the underlying security may be offset by aggressive time decay. We may consider unwinding these warrants if there are material adverse changes to its value with the aim to mitigate the risk.

Country risk

Investments of the target fund in any country may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the target fund invests. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the target fund in those affected countries. This in turn may cause the NAV of the target fund or prices of units to fall.
