PERFORMANCE RECORD



FUND MANAGER'S COMMENTS

The Fund increased 2.25% during the month, outperformed the benchmark by 0.17%

Global financial markets experienced significant volatility in April 2025 as investor anxiety about the impact of US trade policy weighed on stocks, bonds and currencies. The monthstarted with US President Donald Trump's announcement of "reciprocal" tariffs that were more sweeping and severe than many had expected, driving stocks substantially lower.

The information technology (IT) sector in April continued to experience monetary policy- and tariff-driven volatility but ultimately appreciated and outperformed seven out of the 10 other sectors. Tentative signs of renewed confidence in IT were driven by robust demand for artificial intelligence (AI) and tech infrastructure, diversified global supply chains that were seenby many investors as mitigating at least some of the tariff impacts, and signs of fairly stable 1Q25 earnings from major IT firms.

We expect equity market volatility to persist in the near-term, but we remain positive on secular growth in the IT sector in the longer-term. Heading into May, the market was still contending with heightened macroeconomic and policy uncertainty, exacerbated by the introduction of the Trump administration's global trade policy framework on 2 April. Widespreadtariffs, in our view, increase the risks of an economic slowdown, high inflation, and supply-chain disruptions.
