

FUND MANAGER'S COMMENTS

The Fund increased 9.95% during the month, underperformed the benchmark by 0.57%

Global equities collectively rose in May 2025, recovering from April's lows amid easing trade tensions and improving consumer sentiment. The US-China temporary trade deal, progress in US trade talks with the European Union, and the delay in US President Donald Trump's "reciprocal" tariffs soothed investor anxiety about a worldwide recession.

The information technology (IT) sector spearheaded the rally in both US and global equity markets. Tech giants delivered blockbuster fiscal first-quarter 2025 (1Q25) earnings, exceeding revenue and profit expectations driven by sustained demand for artificial intelligence (AI) infrastructure and cloud services. These results alleviated wider concerns aboutpotential slowdowns in AI spending and reinforcing investor confidence. Another significant driver was the temporary US-China trade agreement announced on 12 May, which pausedsteep tariffs on Chinese imports.

Widespread tariffs, in our view, increase the risks of an economic slowdown, high inflation, and supply-chain disruptions. Given the heightened risks in this fluid scenario, we have takenmeasures to reduce portfolio exposure to affected industries and companies. At the same time, we're finding opportunities in companies that we believe are more insulated and alignwell with our long-term positive view on AI and digital transformation. We expect to gain more clarity on the impact from tariffs in the coming weeks and months.
